6 **ORDINANCE 2006-1198-E**

7 AN ORDINANCE ESTABLISHING THE OTC COMMUNITY
8 DEVELOPMENT DISTRICT ("DISTRICT"); DESCRIBING
9 THE EXTERNAL BOUNDARIES OF THE DISTRICT;
10 NAMING THE DISTRICT; NAMING THE INITIAL
11 DISTRICT BOARD OF SUPERVISORS; PROVIDING
12 INFORMATION RELATED TO DISTRICT BOARD REQUESTS
13 FOR CONSENT TO EXERCISE SPECIAL POWERS;
14 AMENDING SECTION 92.22 (EXISTING COMMUNITY
15 DEVELOPMENT DISTRICTS), *ORDINANCE CODE* TO
16 INCLUDE THE DISTRICT; PROVIDING FOR CONFLICT
17 AND SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

19 **WHEREAS**, Argyle Forest Retail I, LLC, a Florida limited
20 liability corporation, petitioned the City Council to establish a
21 community development district ("CDD") named the OTC Community
22 Development District on approximately 98.27^v acres lying wholly
23 within the boundaries of the City pursuant to F.S. Chapter
24 190.005(2) and Chapter 92, *Ordinance Code*, a copy of the Petition
25 to Establish the OTC Community Development District ("Petition") is
26 **on file** with the Legislative Services Division as **Exhibit 1**; and

27 **WHEREAS**, if established as proposed in the Petition, the OTC
28 Community Development District would thereafter exist and operate
29 as an independent special district as set forth in F.S. Ch. 190;

1 **WHEREAS**, the Office of General Counsel and the Planning and
2 Development Department have reviewed the Petition and have
3 submitted their reports thereon to the Council, which are **on file**
4 with the Legislative Services Division as **Exhibit 2** and **Exhibit 3**,
5 respectively; and

6 **WHEREAS**, the Council has determined the Petition adequately
7 meets the requirements of F.S. Ch. 190.005 and Section 92.04,
8 *Ordinance Code* and is therefore complete and sufficient to permit
9 fair and informed review thereof; and

10 **WHEREAS**, all notice requirements of F.S. Ch. 190, Section
11 92.11, *Ordinance Code* and other applicable laws were complied with,
12 and complete notice was timely given, and a public hearing held on
13 the date and time noticed and conducted thereafter in compliance
14 with F.S. Ch. 190 and all applicable laws; and

15 **WHEREAS**, in making its fair and informed determination whether
16 to grant or deny the Petition, the Council has considered the
17 petition in light of the record developed at the public hearing and
18 in relation to the six factors set forth at F.S. § 190.005(1)(e),
19 now, therefore

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Name.** A CDD is hereby established within the
22 City to be known hereafter as the OTC Community Development
23 District.

24 **Section 2. Boundaries.** The boundaries of the OTC
25 Community Development District established by this ordinance are as
26 set forth in the legal description incorporated herein as part of
27 **Exhibit 1** which is **on file** with the Legislative Services Division.

28 **Section 3. Board of Supervisors.** The following five
29 persons, as set forth in the Petition, are designated to be the
30 initial members of the governing Board of Supervisors ("Board") of
31 the OTC Community Development District:

- 1 a. David Murphy
- 2 b. Tom Hareas
- 3 c. Chase Wolf
- 4 d. Robert Fargo
- 5 e. Ralph L. Colton

6 **Section 4. Consent Requests.** After the initial meeting and
 7 swearing in of the OTC Community Development District Board, the
 8 Board may request that the City consent to the OTC Community
 9 Development District's exercise of one or more special powers set
 10 forth in F.S. § 190.012(2), by adopting a proper resolution and
 11 submitting same thereafter to the City to be taken up and
 12 considered pursuant to Section 92.15, *Ordinance Code*.

13 **Section 5.** Chapter 92 (Uniform Community Development
 14 Districts), Section 92.22 (Existing Community Development
 15 Districts), *Ordinance Code*, is amended to read as follows:

16 **CHAPTER 92. UNIFORM COMMUNITY DEVELOPMENT DISTRICTS.**

17 * * *

18 **Sec. 92.22. Existing Community Development Districts**

19 The following CDDs have been established in the City:

21 (12) OTC Community Development District. The OTC Community
 22 Development District was established in Ordinance 2006-1198-E.

24 **Section 6. Conflict and Severability.** Any portion of this
 25 ordinance determined finally by a court of competent jurisdiction
 26 to be in conflict with prevailing law shall not be effective to the
 27 extent of such conflict, and shall be deemed severable and the
 28 remainder shall continue in full force and effect to the extent
 29 legally possible.

1 **Section 7. Effective Date.** This ordinance shall become
2 effective upon signature by the Mayor or upon becoming law without
3 the Mayor's signature.
